

Survey details



- Half-yearly survey of IR professionals (DIRK members)
- Internet-based written survey from 13.09.2013 to 01.10.2013
- Basis: 288 DIRK members (1-2013: 313)
- Responses: 88 = 31% (1-2013: 25%)
- Broken down by indices, the responses came from:
 - 7 DAX companies (= 23% of all DAX-listed companies)
 - 22 MDAX companies (= 44% of all MDAX-listed companies)
 - 9 TecDAX companies (= 30% of all TecDAX-listed companies)
 - 15 SDAX companies (= 50% of all SDAX-listed companies)
 - 35 companies that are not part of a selection index
- 73% of all the companies to have responded belong to the Prime Standard segment

- Half-yearly survey of IR professionals (CIRA members)
- Internet-based written survey from 13.09.2013 to 01.10.2013
- Basis: 59 CIRA members
- Responses: 15 = 25% (1-2013: 18%)








Assessment of current situation of companies in Switzerland from year to year

















Economic assessment shows positive outlook for the future




Assessment of current prospect




The future indicator stands at 46 points in Germany: It rises 29 points compared to spring 2013.

Current number of IR employees (full-time)






Current number of IR employees in Germany (full-time)




Current number of IR employees in Germany (full-time) - Indices






Current sell-side analyst coverage in Switzerland












Comparison of surveys from 2009 to 2012


